



**New Member Match  
Resorts World Catskills - Rules**

1. **Who can enter?** All Players' Club members who are 21 years of age or older with a valid Photo Identification.
2. **When:** May 1, 2019- May 31, 2019
3. **Where?** Players' Club.

**How?** During the Promotional Period any new patron who joins the Players Club for the first time may present a competitor's coupon and redeem that coupon at Resorts World Catskills for a maximum amount of \$500 Free Slot Play. A new card member may receive up to \$500 Free Slot Play without a competitors offer coupon, based on play on day of sign up.

New members first gaming day will be reviewed and these members will receive a New Member mailer with two Free Slot Play offers or two Match Play offers based on their play dominance on slots to tables.
