



**A Million Dollar Double Take  
Resorts World Catskills - Rules**

1. Who can enter? All Players' Club members who are 21 years of age or older with a valid Players' Club Card.
2. When? September 21, 2019 & September 22, 2019 (each a "Promotional Day").
3. Where? Gaming Floor
4. How? Beginning June 1, 2019 Player's Club members who are actively playing with their Players Club card properly inserted in any EGM will earn entries to be eligible to be selected. Beginning June 1, 2019 members playing with their Players Club card properly inserted in any EGM will automatically receive one (1) virtual entry for every one (1) tier points earned on a EGM or Table Game. Members may check any Promotional Kiosk to see their entry totals.

At 10pm on September 21, 2019, five (5) winners will be selected by the MGT promo manager tool. Selected winners will have five minutes to report to the "Promotional Area". If a selected winner does not report within five (5) minutes a new name will be selected. The five selected winners will each be choosing one (1) case out of five (5) cases based on the order in which their names were selected. Upon receiving the case each winner selected the winners will then will open their case that they selected to reveal their Prize. One winner will receive \$1,000,000 in Cash, one winner will receive \$10,000 in Free Play, one winner will receive \$10,000 in Free Play, one winner will receive \$10,000 in Free Slot Play and one winner will in \$10,000 Free Slot Play.
