

- 1. New Genting Rewards Card sign ups must provide valid Photo ID of patrons who are 21 years and older as well as an eligible coupon offer to participate in the New Member Offer program.
- 2. When? January 1 March 31, 2025, during normal Genting Rewards Club hours, each a ("Gaming Day").
