

**Point Multiplier
Resorts World Catskills Rules**

1. **Who can enter?** Genting Rewards members who are 21 years of age or older with a Genting Rewards card.
2. **When?** Wednesday, November 24, 2021 6pm - 10pm
3. **Where?** Promotional Kiosks.
4. **How?** Genting Rewards members may be eligible to insert their Genting Rewards card at the Promotional Kiosk, at a rate of one swipe per day. When they swipe members will receive a point multiplier which will be valid for the Promotional Day. Member's points will be multiplied by the multiplier for all play on the Promotional Day when playing slot machines with the Players' Club card properly inserted and table games. Points earned during the promotional day will be available the following day.
5. **Prizes:** 2x points up to 5x points is awarded at the Promotional Kiosk
