

1. Who can enter: Genting Rewards members who are 21 years of age and older with a Genting Rewards Card.
2. When? During January 1 - March 31, 2024 (the “Promotional Day”) on advertised days for invited players.
3. How? Any day in January, February, March 2024, Genting Rewards members with entries into the electronic drawing drum may be selected during an Everi drawing to receive a prize. Resorts World Catskills staff will announce using the PA system at least every half hour during the advertised time frame indicating the results of the Everi earned entry drawing. As many as (10) winners may be eligible to win \$25 up to \$5,000 in Gift Cards, Free Slot Play, Match Play or Free Bet. During the advertised days, every half-hour to within the hour, members will be notified using the PA system to have their card properly inserted in the EGM and must be actively playing to be selected.
