



Big Game Hot Dog SB
February 11, 2024 Rules

1. To qualify for the Giveaway, the patron must place a wager of \$2 or more involving any NFL team at the retail RWC Sportsbook on the day of the Giveaway. Unredeemed betslips for the current Giveaway Day may not be redeemed on future dates.
2. Qualifying wagering times are Sunday 12:01am to 9:15pm on 1/28/24 and Sunday 12:01am to 9:15pm on 2/11/24 which are timestamped on the betslips.
3. Redemption times are Sunday 1/28/24 from 2:00pm to 10:00pm and Sunday 2/11/24 from 5:30pm to 10:00pm.
4. One qualifying bet slip of \$2 or more will qualify for one food item only.
5. A patron may present more than one bet slip for additional rewards.
6. The employee in control of the food cart will check each betslip to verify that the timestamp is within the correct time frame for the current giveaway before offering the food item and mark the betslip with their initials and license # so that the same betslip cannot be used for an additional food item.
7. Any ticket that has any form of handwriting on it may be disqualified.
8. Aspects of the Hot Dog Giveaway promotion are subject to the approval of appropriate regulatory authorities.
9. R.W.C. may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct whether or not related to the promotion.
10. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.
