



New Year's Eve Drawing
Tuesday, December 31, 2024, Rules

1. Who can enter? All Genting Rewards players who are 21 years of age or older with a valid Genting Rewards Card.
2. When? Tuesday, December 31, 2024, 7:07PM-1:07AM the ("Promotional Day"); 7:07PM-10:07PM and 1:07AM the ("Drawing Period").
3. How? Genting Rewards players with their Genting Rewards card properly inserted in any EGM up to but not limited to twenty (20) winners will be selected by the IGT Random Rewards on the Promotional Day. The selected winners receive their prize on the EGM every hour. Resorts World Catskills staff will announce using the PA system each hour. The IGT Random Rewards will award up to five (5) winners playing at any EGM each half hour. Players will be notified using the PA system to have their card properly inserted in the EGM and must be actively playing to be selected. Announcements will be made declaring the five (5) winners of free play every hour beginning at 7:07PM the ("Promotional Period") up to and including the last drawing at 10:07pm.

At 1:07am five (5) winners be selected to by the IGT Random Rewards for each winner to receive \$5,000 Cash for winning. The winner's name will be announced over the PA system, the winner must claim their prize within 5 minutes from the drawing time they were selected. If the selected winner does not arrive to the designated Promotional Area (will announce Promotional Area on the Promotional Day on the PA system) within 5 minutes a new name will be selected. The winner will report to the Promotional Area.
