

New Card Sign Up Quarter 2 - 2025, Rules

- 1. New Genting Rewards Card sign ups must provide valid Photo ID of patrons who are twenty-one (21) years and older as well as an eligible coupon offer to participate in the New Member Offer program.
- 2. When? April 01 June 30, 2025, during normal Genting Rewards Club hours, each a ("Gaming Day").
- 3. Where? Genting Rewards Club
- 4. How? Genting Rewards Club card sign-up with a valid photo ID and email, on the sign-up day are eligible to receive free slot play based on play for the number of point earnings. For example, for every 100 points a player earns, the player may be eligible to receive \$10. The New Member with earned points may receive \$10 up to \$500 in free play on the first day they sign up based play for the number of points earned for the day. This offer may be available to inactive players who have not been active for the past two years. Members are not able to transfer this offer to anyone else. Each coupon is also set up to only be accepted on the account to which it was issued.
