



## Gucci Leather Crossbody Bag Retail Drawing Saturdays in September 2025 - Rules

1. Who can enter? Genting Rewards members who are twenty-one (21) years of age and older with a Genting Rewards Card.
2. When? Saturdays in September (06, 13, 20 & 27), 2025, (each a "Promotional Day") from 8PM-9PM for the floor-wide drawing.
3. How? Beginning Monday, September 01, 2025, Genting Rewards members who are actively playing with their Genting Rewards card properly inserted in any slot machine or checked in at any table game will earn entries to be eligible for selection. Members will automatically receive one (1) virtual entry for every fifty (50) tier points earned for the drawing. They can also purchase entries at a rate of every twenty-five (25) points equaling one (1) additional entry. One (2) winners will be selected by the Everi system each hour on the "Promotional Day" winning a Gucci Leather Crossbody Bag.

Each Saturday starting at 8:00PM, one (1) winner will be selected by the Everi Virtual Drawing Drum at 8:00pm, and 9:00pm, winners selected each hour will receive a Gucci Leather Crossbody Bag.

The winner's name will be announced over the PA system. Selected winners must claim their prize within five (5) minutes from the drawing time they were selected. If the selected winner(s) do/does not arrive at the designated Promotional Area (will announce Promotional Area on the "Promotional Day") within five (5) minutes the prize may be redrawn up to two (2) times so as not cause a disadvantage or unfairness to the integrity of the promotion. After the two redraws and there is no winner the prize is considered null and void. Should the redraw take more than thirty (30) minutes which would cause interference with the next promotional drawing session then the prize would be forfeited and considered null and void to adhere to the promotional rules for the next drawing session. Members must be present to win.

In the event any winner(s) is/are attending multiple promotional events, an RWC staff member may make known winner(s) is/are on property. The RWC staff member will complete the paperwork with said winner to complete the specific drawing session. The prize may be held for the winner(s) to accept when the winner(s) is/are available for up to thirty (30) minutes allowing sufficient time for said player to claim the prize. The situation is to not cause any disadvantage or unfairness to winner(s) who is/are eligible for all promotions occurring at the same time or close to the same drawing times. Should any such player not show to claim the prize within the thirty (30) minutes the player forfeits the prize. Should this circumstance occur, the Gaming Commission will be notified to ensure the integrity of the drawing.

Members may only win once per Promotion and must be present. To activate entries, members must have played at a slot machine one (1) hour prior to the drawing on each Saturday in September 2025.

Entry multiplier is earned on Thursdays advertised based on tier, Red Card tier earns 2x, Silver Card tier earns 3x, Gold Card tier earns 4x, Platinum Card tier earns 5x and Black Card tier earns 6x.

4. Prizes: a Gucci Leather Crossbody Bag (valued at \$1,120). One (1) winner for one (2) hours equaling one (2) winners each Saturday the ("Promotional Day"). A total of eight (8) winners will each receive a Gucci Leather Crossbody Bag for the "Promotional Period".

5. Prize Acceptance: The floor-wide drawing winners must be present. All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the members. In addition, RWC has the right to void any entry, and/or to change, cancel or modify this promotion at any time with NYSGC approval. Participation in this promotion is an agreement to abide by all rules of the promotion and official rules of RWC.

9. Due to unforeseen circumstances not caused by any actions of RWC when the property is unable to perform a promotion, tournaments or anything of the like, RWC will invoke 'force majeure' including but not limited to any 'Acts of God' such as acts, events or disasters due to strike, property closure, explosion, natural disaster, act by a public enemy, fire, flood, accident, war, riot, insurgence, structural, electrical or any other similar event that would go beyond the control of any RWC staff member which has not caused by any negligence or failure to exercise said promotion(s) or tournament(s).

10. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.

11. Should the minimum number of players not be met due to weather or participation [up to 25%] may be required to be checked in on the Promotional Day. Participation minimums may be determined by the total number of players with active entries in the virtual drum at the time of drawing over the earning period. The setting of the minimum is an effort to promote fairness in retail promotions for all participants who have earned over a length of time.

For promotions involving the earning of points, it is the member's responsibility to confirm their card is inserted and registering play or being actively rated in table games to be qualified for earning points. Any offers pertaining to entries, points, redemptions or Free Play may be available on the RWC app which is not used by expiration day/time will be forfeited.
