

1. Who can enter? Genting Rewards members who are twenty-one (21) years of age and older with a Genting Rewards Card.
2. When? Monday, December 01, 2025 to Wednesday December 31, 2025, the ("Promotional Period"); Wednesday, December 31, 2025 from 7:26PM-11:26PM and 1:00AM the ("Drawing Period") as advertised.
3. How? On Monday, December 01 to Wednesday, December 31, 2025 Genting Rewards members who are actively playing with their Genting Rewards card properly inserted in any slot machine or checked in playing at any table game will earn entries to be eligible for selection on the "Promotional Day" from 7:26pm to 10:26pm, six (6) winners will receive two hundred (\$200) in free slot play each hour. At 11:26pm one (1) winner will receive \$2,600 cash and at 1:00am two (2) winners will receive \$13,000 cash. The prizes are awarded by the Everi virtual drawing drum.

Members must be playing with their Genting Rewards card properly inserted in the slot machine and/or checked in to any table game (1) one hour prior to the drawing which activates entries for eligibility into the drawing.

The winner's name will be announced over the PA system. Selected winners must claim their prize within five (5) minutes from the drawing time they were selected. If the selected winner(s) do/does not arrive at the designated Promotional Area (will announce Promotional Area on the "Promotional Day") within five (5) minutes the prize may be redrawn as to not cause a disadvantage or unfairness to the integrity of the promotion. Should the redraw take more than thirty (30) minutes would cause interference with the next promotional time, then the prize would be forfeited to adhere to the promotional rules for the next drawing session. In the event a system failure occurs the drawing will be conducted through IGT Random Rewards drawing.

4. Prizes: Six (6) winners will receive \$200 Free Slot Play, one (1) winner will receive two thousand six hundred (\$2,600) Cash and two (2) winners will receive thirteen thousand (\$13,000) Cash (per stated drawing hour). A total of twenty-four (24) winners will receive four thousand eight hundred (\$4,800) in Free Slot Play, and three (3) winners will receive twenty-eight thousand six hundred (\$28,600) in Cash.
