

1. Who can enter? Genting Rewards members who are twenty-one (21) years of age and older with a Genting Rewards Card.
2. When? Monday, July 27, 2026 to Saturday, August 29, 2026, (the "Earning Period") at 9:30PM on Friday, August 28 & at 4:00PM on Saturday, August 29 (the "Promotional Period") for a floor wide drawing.
3. How? Beginning Monday, July 27, 2026, Genting Rewards members who are actively playing with their Genting Rewards card properly inserted in any slot machine or checked in at any table game will earn entries to be eligible for selection on Friday, August 28 at 9:30pm and Saturday, August 29, 2026 at 4:00PM to win \$15,000 total Cash each day. Three (3) winners will be selected by the Everi Virtual Drawing Drum at 9:30pm on Friday and 4:00pm on Saturday to receive \$5,000 CASH per winner each day.

Members playing with their Genting Rewards card properly inserted in any slot machine and or table game will automatically receive one (1) virtual entry for every fifty (50) tier points earned for the floor wide drawing. They can also purchase entries at a rate of every twenty-five (25) points equaling one (1) additional entry.

On Friday, August 28, 2026 at 9:30pm and Saturday, August 29, 2026 at 4:00pm, members must be playing with their Genting Rewards card properly inserted in the slot machine and or table game one (1) hour prior to the drawing which activates entries for eligibility into the drawing.

The winner's name will be announced over the PA system. Selected winners must claim their prize within five (5) minutes from the drawing time they were selected. If the selected winner(s) do/does not arrive at the designated Promotional Area (will announce Promotional Area on the "Promotional Period") within five (5) minutes the prize will be redrawn until a winner is declared as to not cause a disadvantage or unfairness to the integrity of the promotion. Members may only win once per Promotion, must be present to win and present a valid photo ID.

In the event any winner(s) is/are attending multiple promotional events, an RWC staff member may make known winner(s) is/are on property. The RWC staff member will complete the paperwork with said winner to complete the specific drawing session. The situation is to not cause any disadvantage or unfairness to winner(s) who is/are eligible for all promotions occurring at the same time or close to the same drawing times. Should this circumstance occur, the Gaming Commission will be notified to ensure the integrity of the drawing.

Entry multiplier is earned on Thursdays advertised based on tier, Red Card tier earns 2x, Silver Card tier earns 3x, Gold Card tier earns 4x, Platinum Card tier earns 5x and Black Card and/or Chairman Card (top tier card) tier earns 6x.

In the event a system failure occurs the drawing will be conducted through IGT Random Rewards drawing. The Gaming Commission will be notified immediately by an RWC Marketing team member. An email will be sent to the Gaming Commission outlining the details of the occurrence and the reason for the failure.

4. Prizes: Three (3) winners on Friday, August 28 will receive \$5,000 Cash each day and Three (3) winners on Saturday, August 29 will receive \$5,000 Cash. A total of thirty thousand (\$30,000) dollars will be awarded for the "Promotional Period".
5. Prize Acceptance: For the floor wide drawing winner must be present. All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the members. The members are responsible for all taxes. By accepting a prize, the members acknowledge all restrictions, expiration dates and liabilities.
