

1. Who can enter? Genting Rewards players who are twenty-one (21) years of age and older with a Genting Rewards Card.
2. When? Saturday, October 31, 2026, at 10pm ("Promotional Day").
3. How? Beginning Monday, September 28, 2026, Genting Rewards players who are actively playing with their Genting Rewards card properly inserted in any slot machine or checked in at any table game will earn entries to be eligible for selection on Saturday, October 31, 2026, at 10pm to win a 2026 Chevy Silverado 1500 OR forty-thousand dollars (\$40,000).
Members playing with their Genting Rewards card properly inserted in any slot machine and or table game will automatically receive one (1) virtual entry for every fifty (50) tier points earned.
