

1. Who can enter? Genting Rewards members who are twenty-one (21) years of age and older with a Genting Rewards Card.
2. When? Monday, August 31, 2026 to Saturday, September 26, 2026, (the "Earning Period"). Each Friday and Saturday in September [04, 05, 11, 12, 18, 19, 25, 26] (the "Drawing Period"), 2026 from 6:00pm to 9:00pm on Fridays and Saturdays for a floor wide drawing.
3. How? Beginning Monday, August 31, 2026, Genting Rewards members who are actively playing with their Genting Rewards card properly inserted in any slot machine or checked in at any table game playing will earn entries to be eligible for selection each Friday from 6:00pm to 9:00pm and each Saturday from 6:00pm to 9:00pm. Two (2) winners will be selected by the Everi Virtual Drawing Drum each hour to play Harvest Bonus Bash Board Game prize, winning Free Slot Play. Each winner will select a numbered ball from the pot. The number drawn from the game box will match a number on the game board. The matching number will be turned on the game board to reveal the amount of Free Slot Play prize won. The Free Slot Play prize shown on the back of the game board will be added to the patron's account through IGT.

The numbers are one (1) through nine (9). There will be four (4) \$200, two (2) \$300, two (2) \$400 and one (1) \$500 Free Slot Play prizes totaling nine (9). When a number is selected it will NOT be returned to the pot. The prize pool will NOT remain constant. When the game board number is turned, it will remain turned for the "Drawing Period" each day. The total number of winners for each day will be eight (8) and there is a total of nine (9) squares on the game board. Before the start of each Promotional drawing day the numbers will be jumbled up and/or shuffled before the drawing starts.

Members playing with their Genting Rewards card properly inserted in any slot machine and or table game will automatically receive one (1) virtual entry for every fifty (50) tier points earned for the floor wide drawing. They can also purchase entries at a rate of every twenty-five (25) points equaling one (1) additional entry.

On Fridays and Saturdays in September 2026, the winner's name will be announced over the PA system. The selected winner must claim their prize within five (5) minutes from the drawing time they were selected. If the selected winner does not arrive at the designated Promotional Area (will announce Promotional Area on the "Drawing Day" on the PA system) within five (5) minutes a new name or names will be selected one (1) time filling the missing position for each hour should there be no shows to not cause a disadvantage or unfairness to the integrity of the promotion. The total number of winners will not be more than eight (8) for each "Promotional Day". Members may only win once per "Promotional Day" and must be present to win.

Members must be playing with their Genting Rewards card properly inserted in the slot machine and/or checked into any table game one (1) hour prior to the drawing to activate entries for eligibility into the drawing.

Entry multiplier is earned on Thursdays advertised based on tier, Red Card tier earns 2x, Silver Card tier earns 3x, Gold Card tier earns 4x, Platinum Card tier earns 5x and Black and/or Chairman Card (top tier card) tier earns 6x.

In the event a system failure occurs the drawing will be conducted through IGT Random Rewards drawing. The Gaming Commission will be notified immediately by an RWC Marketing team member. An email will be sent to the Gaming Commission outlining the details of the occurrence and the reason for the failure.

4. Two (2) winners selected each hour during the "Drawing Day" winning \$200 up to \$500 Free Slot Play. A total of sixty-four winners sharing up to nineteen thousand two hundred (\$19,200) dollars Free Slot Play for the Promotional Period.
5. Prize Acceptance: Free Slot Play winner(s) is/are communicated the expiration date at time of winning. The Free Slot Play will expire after seven (7) days. For the floor wide drawing winner must be present. All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the members. The members are responsible

for all taxes. By accepting a prize, the members acknowledge all restrictions, expiration dates and liabilities. The members may be required to complete and execute an Affidavit of Eligibility/Release of Liability, a Publicity Release and an IRS W-9. No substitution of a prize by the member will be permitted unless otherwise stated in the official rules. Prizes may not be transferable, assignable or redeemable for cash.

9. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.
10. Should the minimum number of players not be met due to weather or participation [up to 25%] may be required to be checked in for the "Promotional Period". Participation minimums may be determined by the total number of players with active entries in the virtual drum at the time of drawing over the earning period. The setting of the minimum is an effort to promote fairness in retail promotions for all participants who have earned over a length of time.

For promotions involving the earning of points, it is the member's responsibility to confirm their card is inserted and registering play or being actively rated in table games to be qualified for earning points. Any offers pertaining to entries, points, redemptions or Free Play may be available on the RWC app which is not used by expiration day/time will be forfeited.
